



COURT RULES

1. By purchasing an admission ticket or season ticket, or by registering for entry, the participant of the sports event (hereinafter referred to as the "Participant") accepts the venue regulations as binding upon themselves.

In addition to the provisions of the venue regulations, the Participant shall comply with the rules determined by the organiser, as well as the instructions of the organiser, the stewards and the police.

- **2.** The Participant may be admitted to the venue of the sports event only if they:
- hold a valid admission ticket, season ticket or other document entitling them to enter the venue of the sports event, including an invitation or accreditation;
- consent to the inspection of their clothing and baggage;
- are not manifestly under the influence of alcohol, narcotics or other intoxicating substances;
- do not possess alcoholic beverages, narcotics, or any object that may endanger the holding of the sports event or the personal safety and property of others, or the entry of which to the sports event has been prohibited by the organiser prior to the purchase of the admission ticket, and about which the ticket purchaser was duly informed;
- do not possess symbols of totalitarian regimes prohibited by law, or inscriptions or flags inciting hatred against others;
- are not subject to an exclusion pursuant to Section 73(1) of Act I of 2004, a ban from attending sports events, a misdemeanour-related exclusion, or a decision of a foreign sports organisation, authority or court of similar content pursuant to Section 76/A(1);
- undertake to verify their identity at the request of the steward;
- acknowledge that image and audio recordings may be made of them during the sports event;
- do not bring food or beverages into the venue and only carry personal items strictly necessary for attending the sports event;
- do not bring animals into the sports facility, with the exception of assistance dogs accompanying spectators with disabilities;
- do not possess video cameras, professional photographic equipment or items intended for commercial use, unless they hold prior authorisation from the organiser.
- 3. The Participant acknowledges that:
- stewards providing security services and police officers are entitled to inspect the clothing and baggage of persons attending the sports event and, in the event of a misdemeanour or criminal offence, to remove or detain them;
- in addition to personal belongings and in compliance with the venue regulations, only the official national flags and symbols of the competing teams and the official flags and symbols of the competing club teams may be brought into the venue; national flags may display only the names of the country's official cities; the entry of any other banners or the display of choreographies is subject to the organiser's prior approval;
- entry to the sports facility is permitted exclusively through the access gate indicated on the admission ticket, season ticket or invitation;
- they may approach their designated sector or place of work only via the designated routes;
- they may occupy only the seat indicated on their admission ticket, season ticket or invitation;





- they are obliged to comply with the provisions of the venue regulations, the rules determined by the organiser, and the instructions of the organiser, stewards and police;
- they may leave the sports facility only through the exit point, unless otherwise instructed by the organiser, steward or police.
- **4.** At the sports event, the Participant shall not:
- engage in any activity that disturbs, obstructs or endangers the orderly conduct of the sports event or the personal safety and property of participants;
- throw objects onto the field of play, into areas closed to spectators, or at other persons;
- enter the field of play or areas closed to spectators without authorisation;
- possess or use pyrotechnic devices, lasers or signal lights;
- cause fire and must comply with fire safety regulations;
- stop on escape routes (including stairways) or obstruct escape routes or emergency exits, which must be kept clear at all times;
- display racist, hate-inciting, offensive or otherwise disturbing behaviour, or behaviour that may be considered ideological, religious or political in nature, nor display inscriptions or signs of such content;
- place banners or flags on fences, railings or poles without the organiser's permission, and such items may not obstruct advertisements;
- climb on fences or structures of the sports facility;
- obstruct the view of other spectators;
- stand on seats;
- cover their face;
- litter, and must comply with regulations related to smoking.
- **5.** The organiser shall be obliged to call upon any Participant who endangers the holding of the sports event or the personal safety and property of others, or who engages in racist, hate-inciting, fear-inducing or otherwise offensive behaviour unrelated to fair and sportsmanlike support, to cease such conduct.
- **6.** If the Participant does not meet the conditions set out in the venue regulations, or engages in unlawful conduct and fails to cease such conduct upon warning by the steward, entry shall be refused or the Participant shall be removed from the sports event.

A person may also be excluded from participation in the sports event if they have been removed pursuant to the applicable Sports Act, or if removal did not take place because organiser (steward) intervention at the venue would have posed a disproportionate risk to the safety of the sports event; in such cases, the organiser shall exclude the person from participation.

Any person who otherwise violates the venue regulations may also be excluded.

7. In the case of sports events organised by the organiser, the organiser shall refuse to sell admission tickets to persons removed from a sports event and shall prevent them from attending the sports event (hereinafter: exclusion from participation in sports events).

The organiser shall inform the public of the possibility of exclusion from participation in sports events by means of a clearly visible notice both outside and within the sports facility.

The duration of exclusion from participation in sports events shall not be less than six months and shall not exceed two years in the case of exclusion from all sports events organised by the organiser, or four years in the case of exclusion limited to a specific sports facility.





A decision on exclusion from participation in sports events may be challenged before a court. Within three days, the organiser shall forward the excluded person's name, place and date of birth, image, duration of exclusion, the name of the sports facility, and the scope of sports events to which the exclusion applies, to the sports policing register.

The organiser shall process exclusion decisions and the personal data contained therein in compliance with data protection regulations for the duration of the exclusion.

The organiser shall notify the excluded person and the police in writing of the exclusion.

The written notice of exclusion shall specify:

- the act serving as the basis for the exclusion, including its time and place;
- the duration of the exclusion;
- the sports events and/or sports facilities to which the exclusion applies;
- the fact that the data of the excluded person specified in Section 91/J (1) point b) of Act XXXIV of 1994 on the Police shall be recorded by the Police for one year following the expiry of the exclusion period.
- **8.** The use of coercive measures is exclusively permitted to police officers.
- **9.** The organiser shall ensure the documented collection, secure storage and return, upon departure, of items that are prohibited from being brought into the venue under the venue regulations. Food, beverages and medication may not be accepted for safekeeping. If the owner does not claim the deposited items within two hours following the end of the sports event, the organiser shall thereafter proceed in accordance with the rules governing responsible custody.
- **10.** Any person who resists a lawful measure taken by a steward for the purpose of maintaining order by means of force or threat, enters an area closed to spectators, or throws an object that endangers the holding of the sports event or the physical integrity of others, commits a criminal offence.
- **11.** Any damage resulting from a breach of the safety regulations shall be borne by the Participant; in the event of multiple persons causing damage, those involved shall be jointly and severally liable. The person causing the damage shall reimburse the organiser for all costs arising from the damage.
- **12.** The organiser or, where stewards are engaged, the stewarding body shall be entitled to monitor the sports event during its duration by means of cameras installed in numbers determined by the police and capable of producing recordings suitable for the individual identification of Participants, and to record such footage.

For the purpose of providing data and information necessary for initiating and conducting misdemeanour or criminal proceedings, following the conclusion of the sports event the organiser shall retain the recordings made during the securing of the sports event for the period specified in a request issued by the police within 120 hours following the end of the sports event (for a maximum period of 60 days).

If no such request or data demand is received, the organiser shall delete the recorded data upon the expiry of 120 hours from the time of recording.

13. The organiser has taken out public liability insurance for persons holding admission tickets, season tickets or invitations; in the case of sports events, the existence of such liability insurance is also indicated on the tickets and season tickets.





14. In order to ensure the safe departure of spectators, the police may detain opposing supporter groups within the sports facility.

If the police are not present at the sports event, the organiser may independently decide on such detention within the sports facility.

15. If the sports event is cancelled, or is held with spectators excluded or with restricted spectator numbers, the purchase price of the admission ticket shall be refunded within three working days. If the sports event is interrupted, the admission ticket and season ticket shall remain valid for the rescheduled sports event.
